7. CANADA Optional Services – select according to the travel policy
8. Complete remaining fields and submit enrollment form
9. You will receive your Hertz #1 Club Gold Number via a printable member card on the screen

In order to protect you from misuse of your #1 Club Gold profile, please note that for your first Gold rental, you will need to approach the Gold counter to show personal identification.

Your #1 Club Gold number will be returned to you instantly, but you must wait 5-7 working days before it can be used in order for your information to be confirmed by Hertz.

#### Overview of the Hertz Program

- For use by all State of Oregon Agencies, Political Subdivisions and Non-Profit Corporations, Participating Institutions of Higher Education (College & Universities, Community & Technical Colleges).
- The State Contract includes LDW/Liability Coverage for Official Rentals only. The CDP # must be noted on the Rental Agreement. If the terms of the rental agreement are violated, LDW/Liability Coverage will not apply.
- Drivers must have a Valid Drivers License and Credit Card and be at least 18 years of age at participating locations.
- State issued Corporate Credit Cards and personal credit cards are acceptable Forms of Payment.
- Hertz has Direct Billing Programs available for your convenience. If you are interested in setting up a Direct Billing Program, contact Carole Weir, Sr Account Representative at [cweir@hertz.com](mailto:cweir@hertz.com) or 503-626-5156.
- Accidents – you must promptly report any accident, theft or vandalism involving the car to Hertz and to the police.
- Airport Concession Fees and Taxes are a separate charge and are not covered under the Contract Agreement.
- One-way rentals are charged \$125.00 if exceeding 500 miles.
- NeverLost (GPS) and Sirius Radio are available for an additional fee.
- International Discounts apply.
- It is recommended that you fill up the gas tank prior to return.
