National Car Rental: Direct billing requires both the appropriate Primary Account Number (above) as well as an additional ID number unique to your department, organization or entity. Your additional ID number created for billing with National Car Rental will NOT work at Enterprise Rent-A-Car.

Enterprise Rent-A-Car: For direct billing with Enterprise, use your already established billing account number instead of the primary account numbers listed above. Billing account numbers at Enterprise Rent-A-Car start with DB, GA, or 46OR. Your Enterprise Rent-A-Car billing account number will NOT work at National Car Rental
