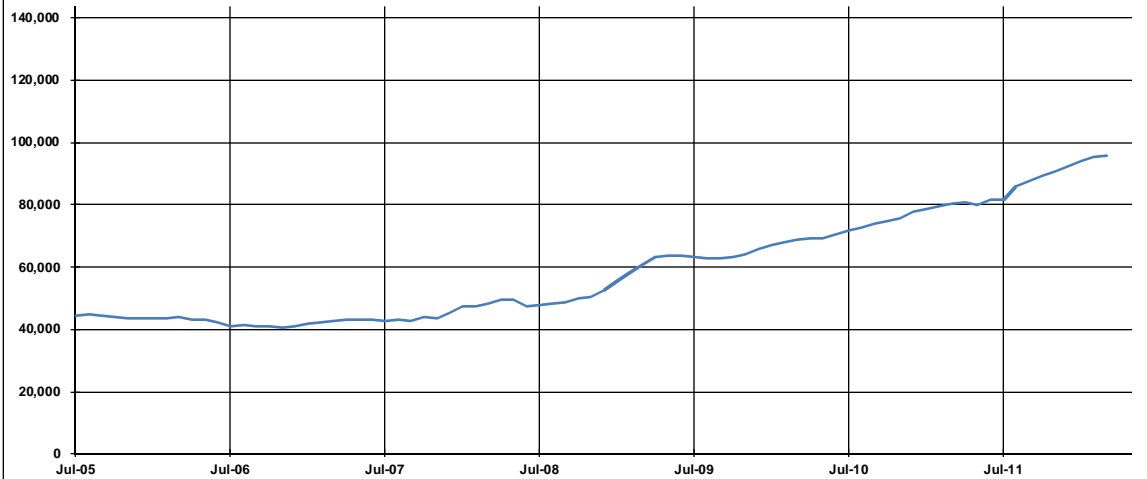

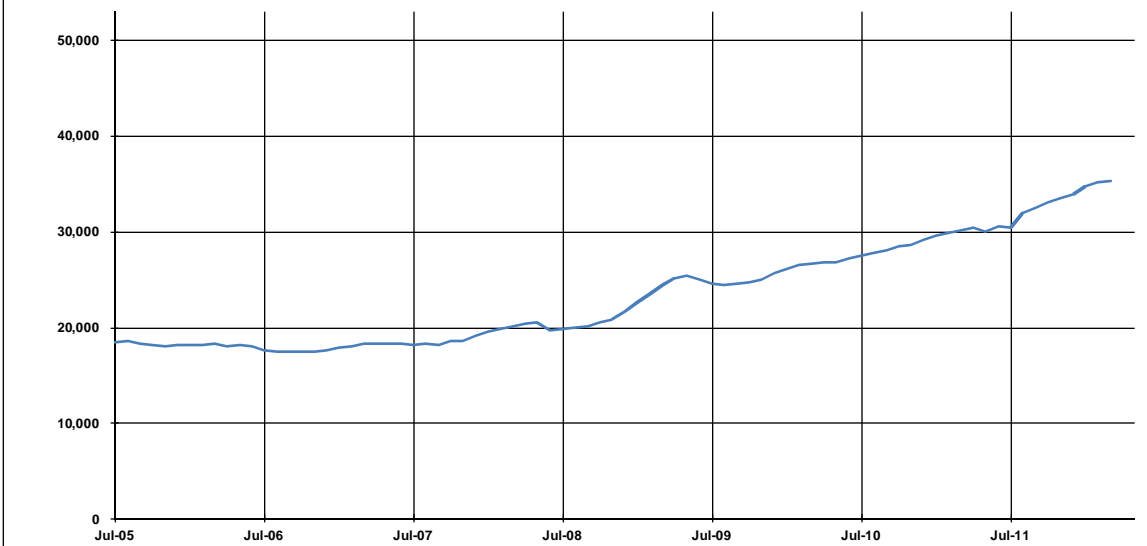
Temporary Assistance for Needy Families (TANF) One- and Two-Parent Program Person Count

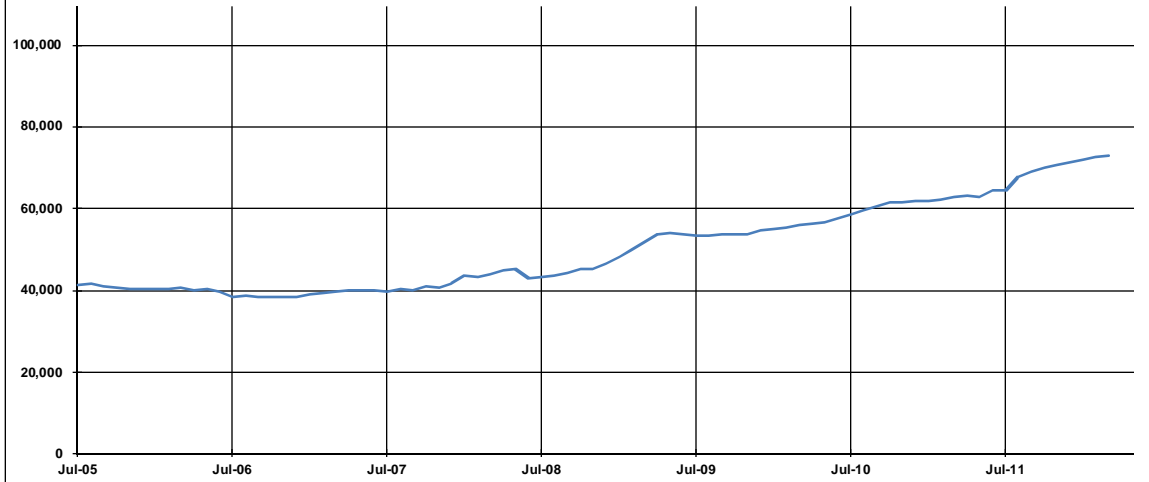
TANF One- and Two-Parent Program Case Count

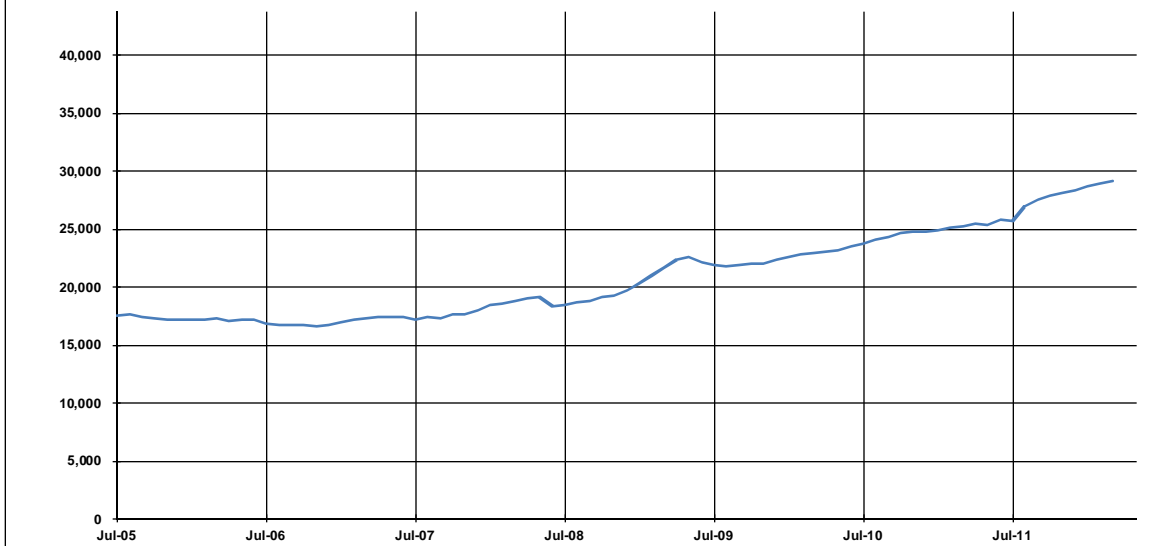
TANF One-parent Program Persons (TANF-Basic)

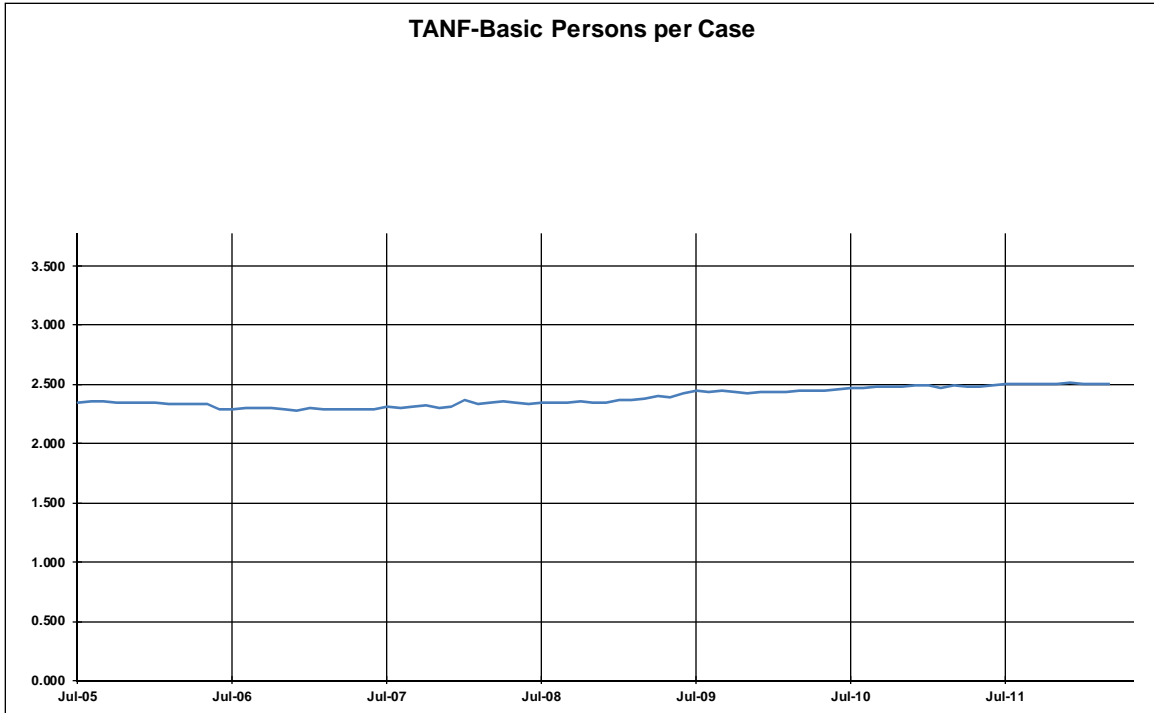

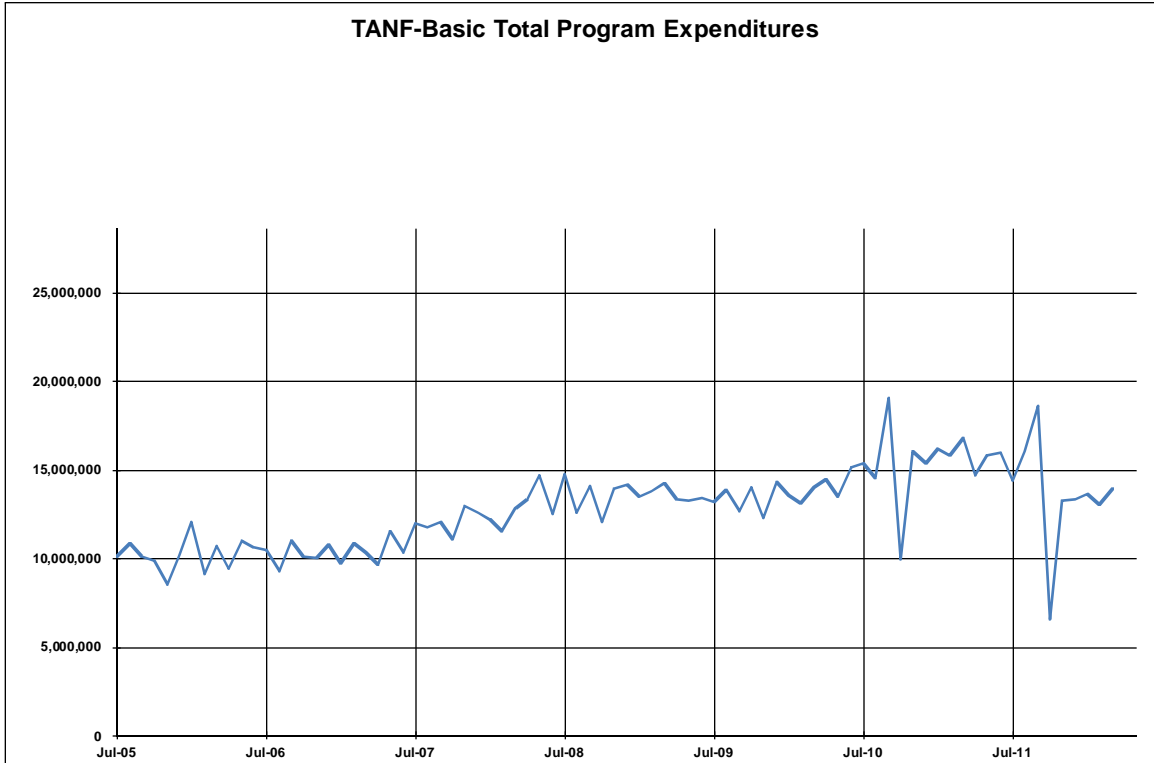
TANF-Basic Persons per Case

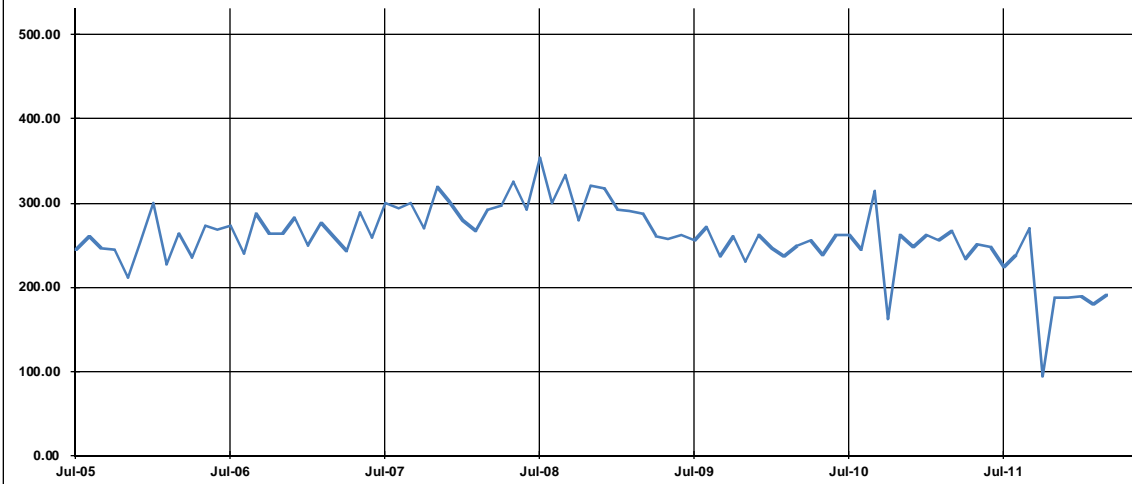
TANF-Basic Total Program Expenditures

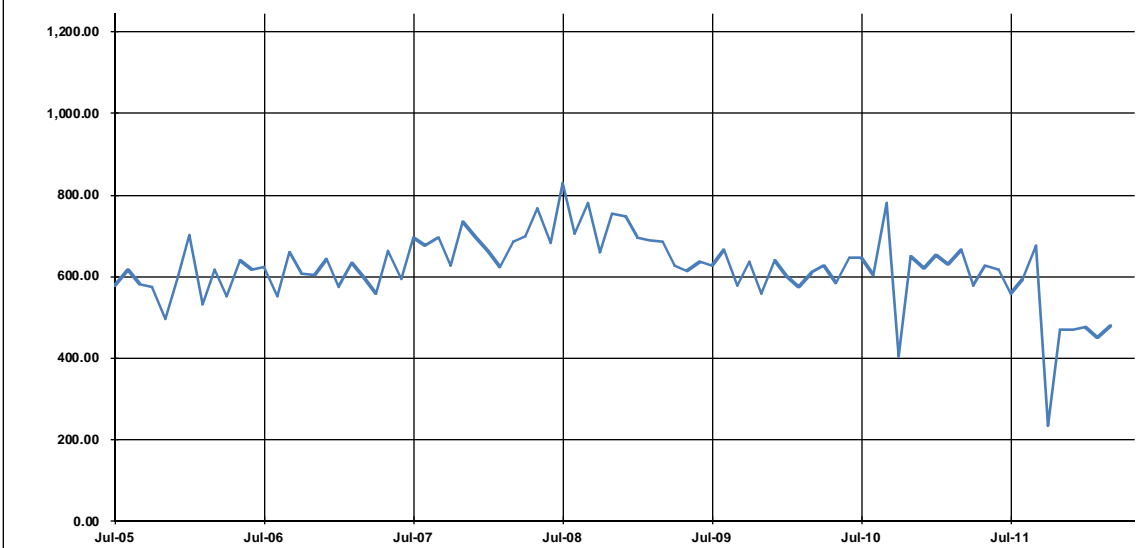
TANF-Basic Total Program Cost per Person

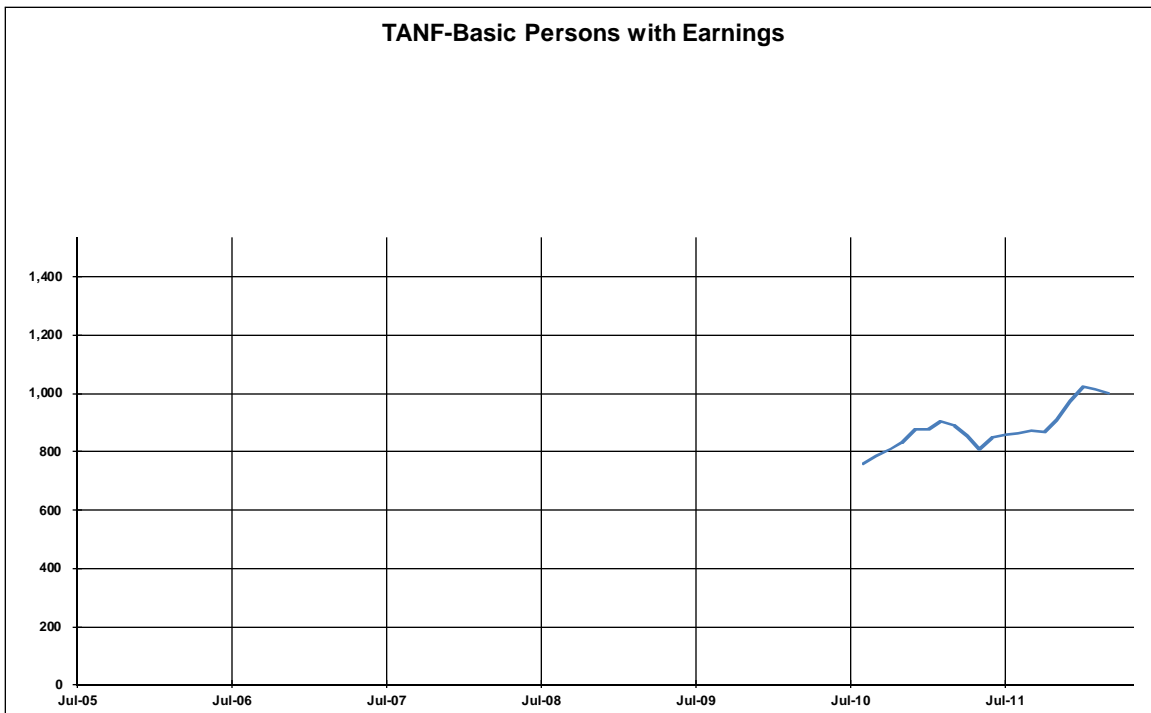
TANF-Basic Total Program Cost per Case

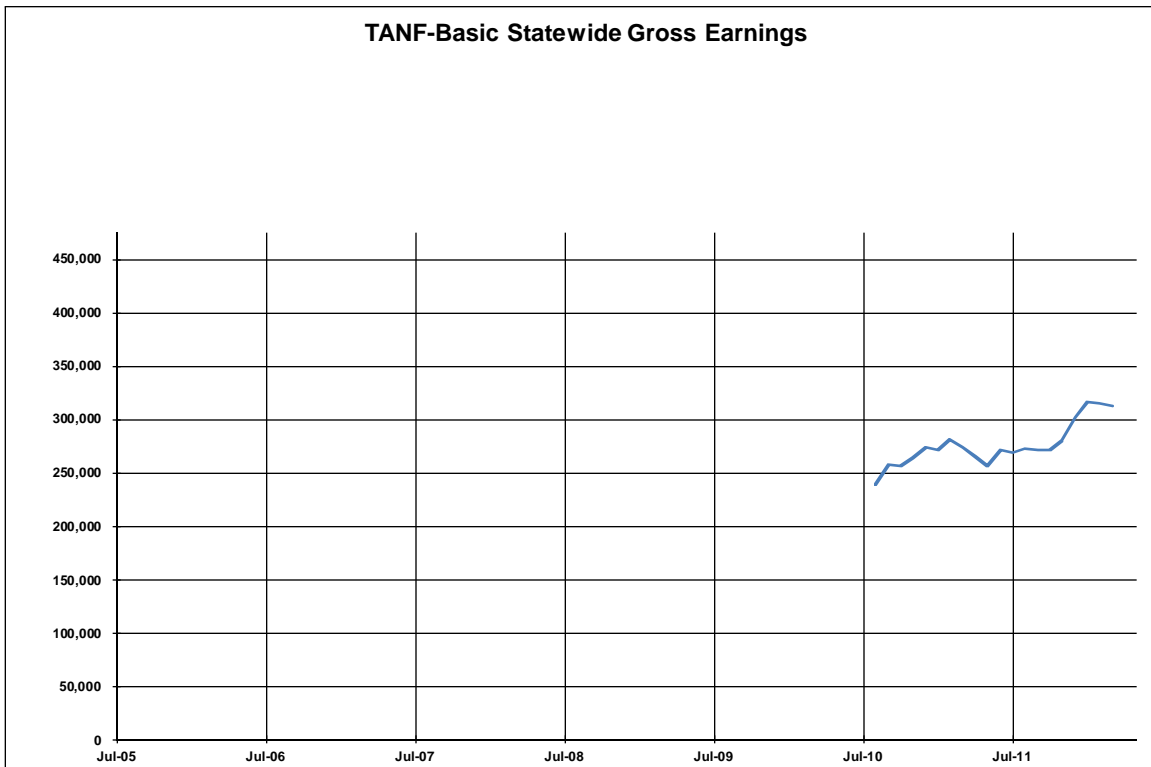

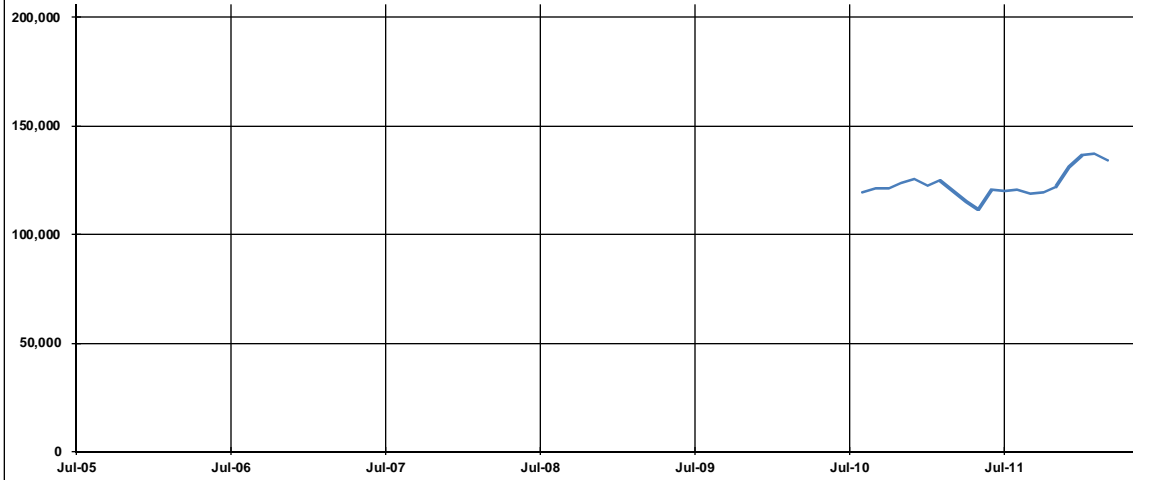
TANF-Basic Statewide Gross Earnings

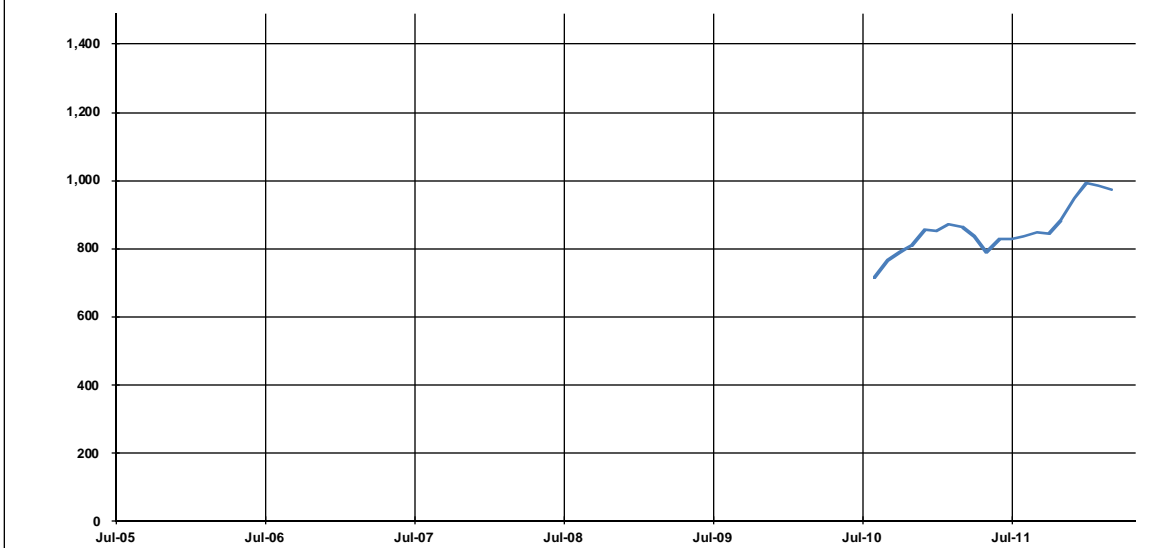
TANF-Basic Earnings Applied to Grant

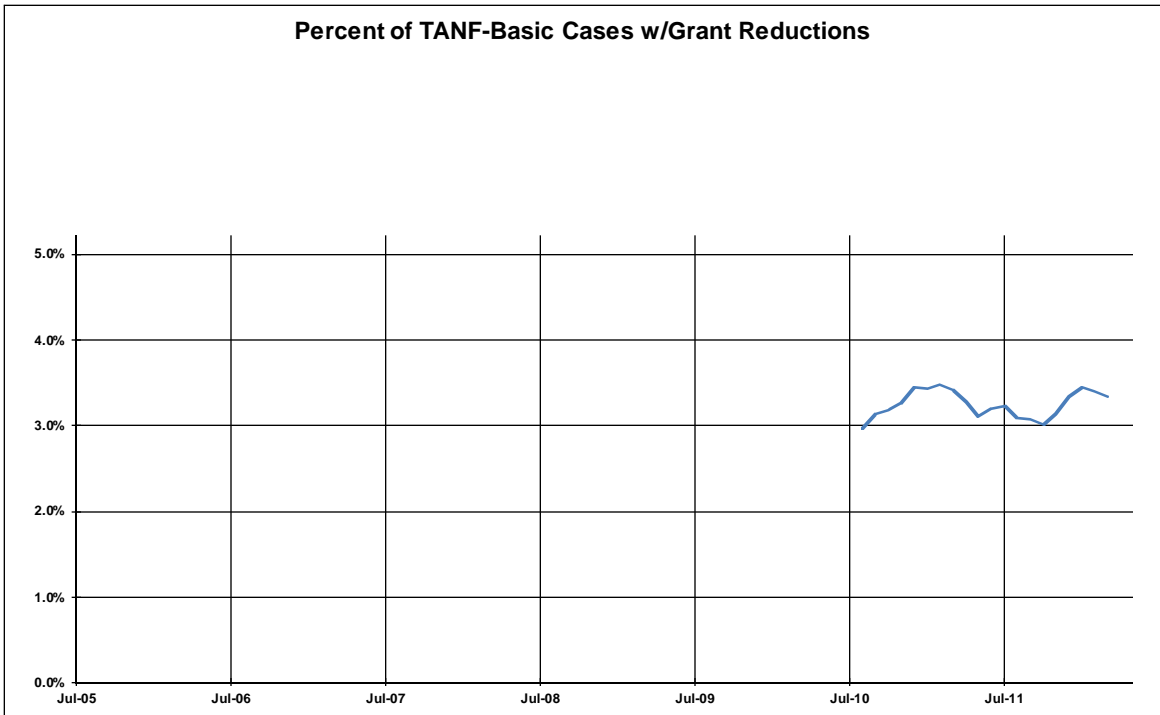

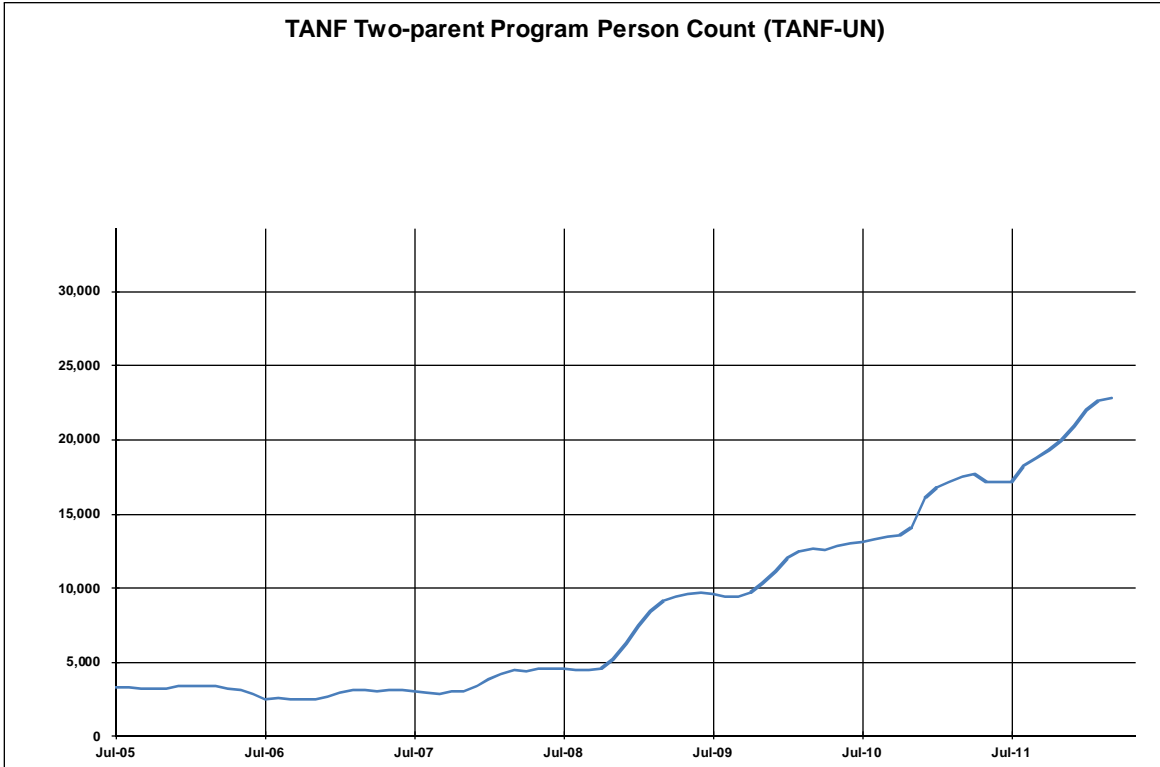
Percent of TANF-Basic Cases w/Grant Reductions

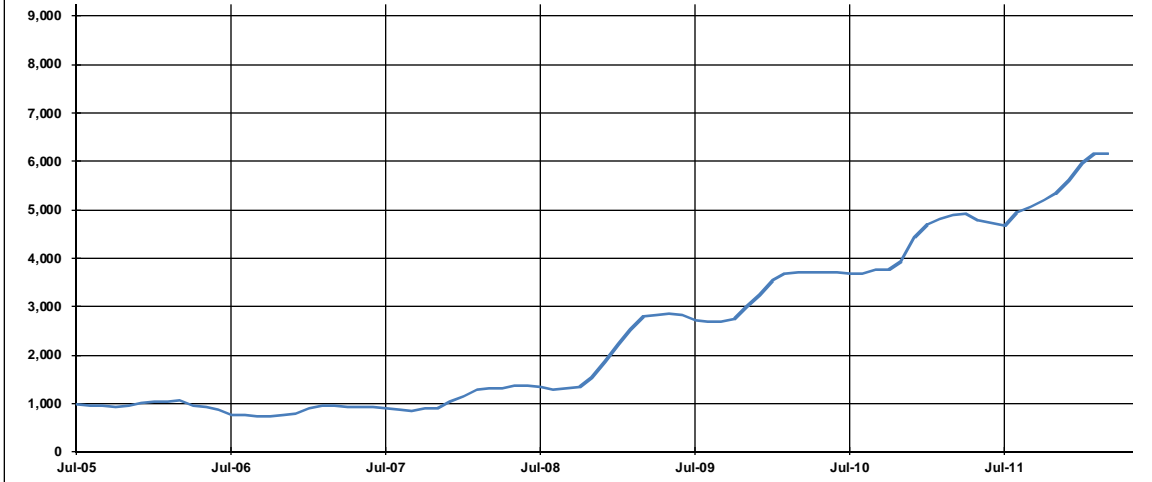
TANF Two-parent Program Person Count (TANF-UN)

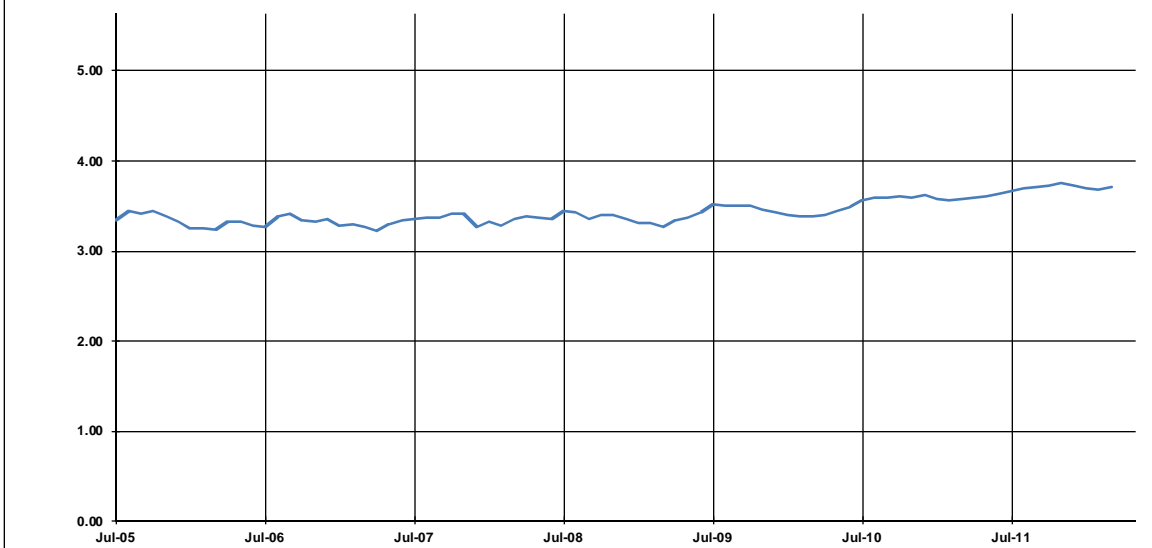
TANF Two-parent Program Case Count (TANF-UN)

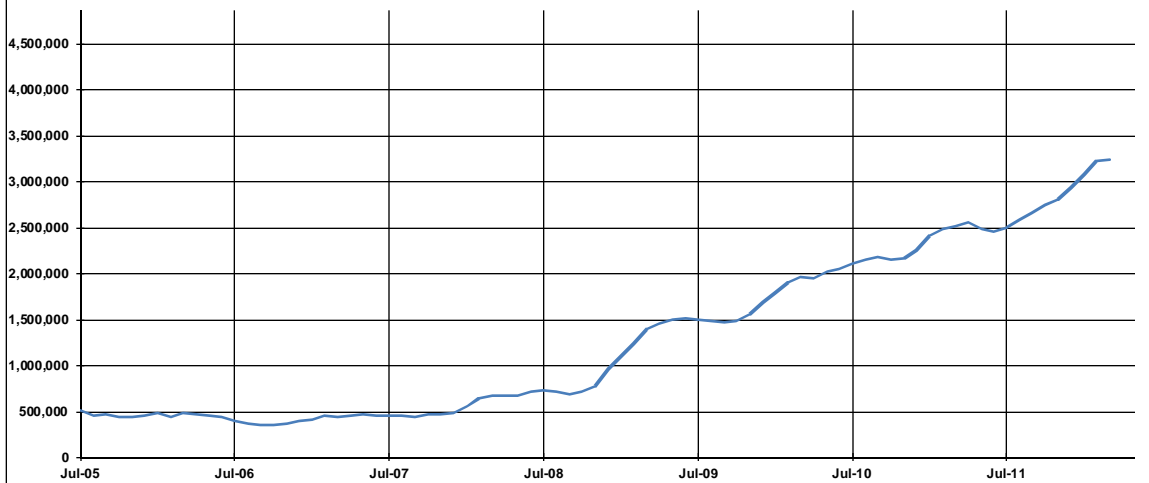

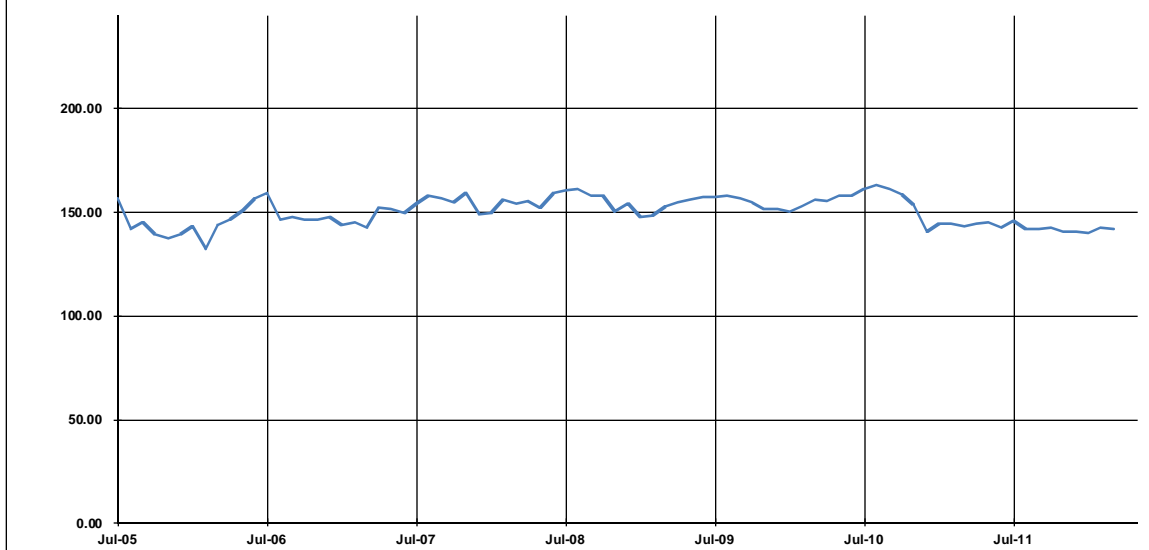

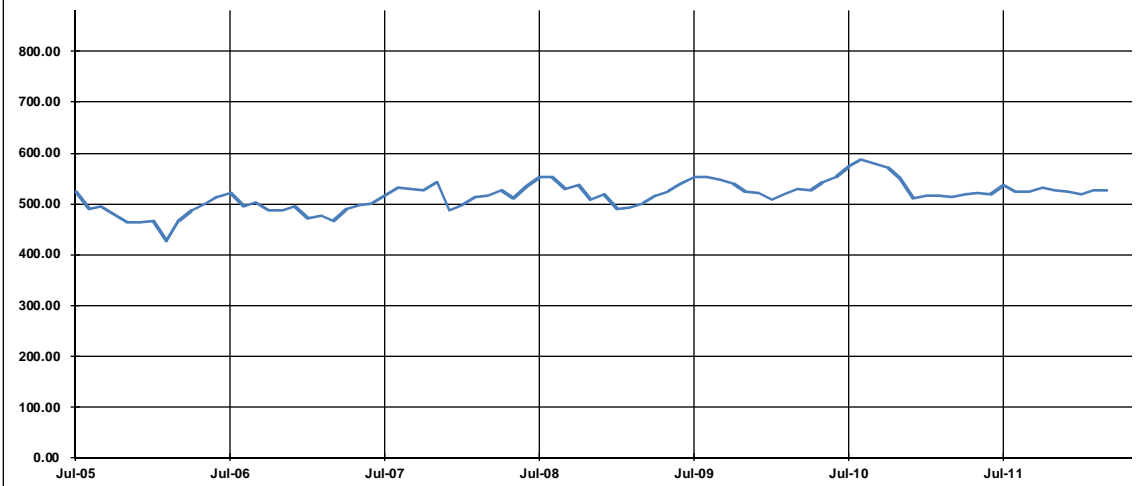
TANF-UN Total Cost per Person

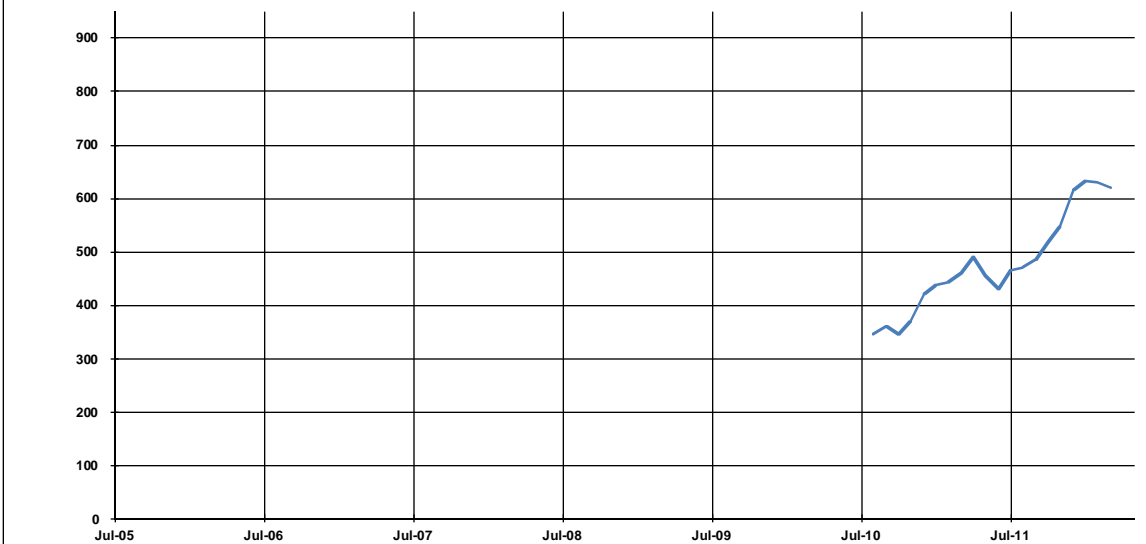
TANF-UN Total Cost per Case

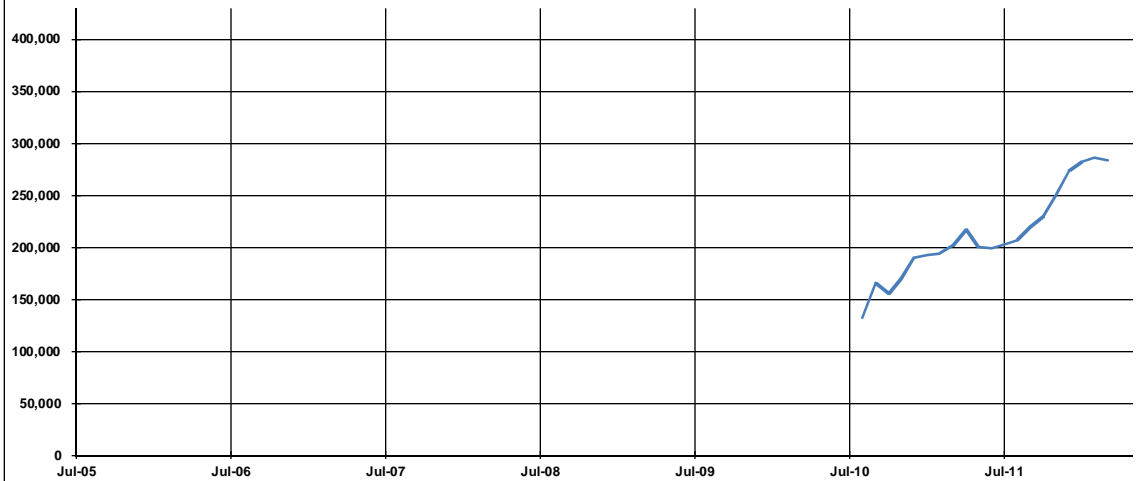

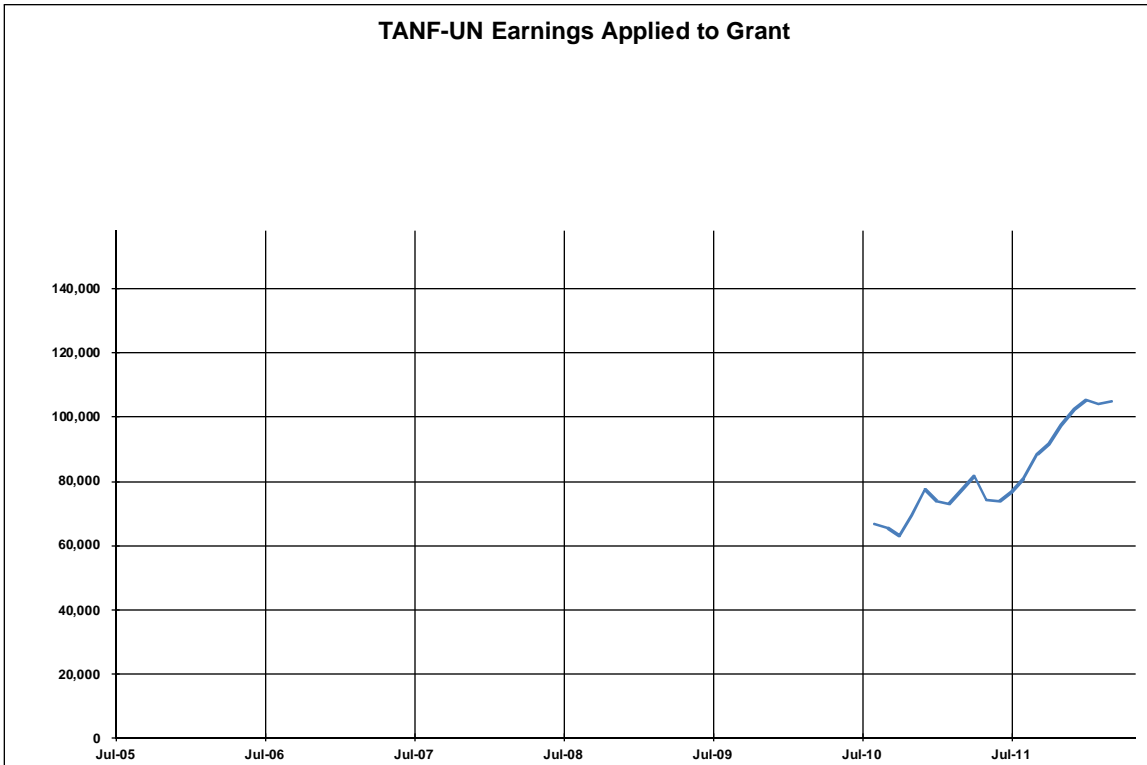
TANF-UN Statewide Total Gross Earnings

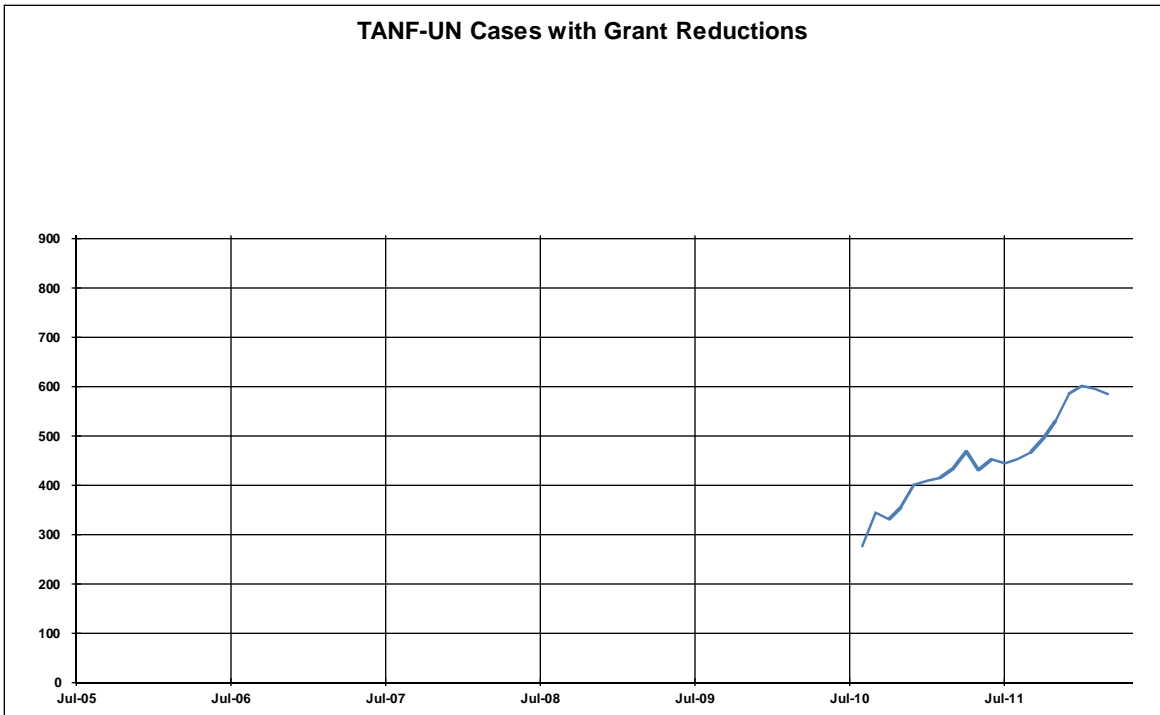
TANF-UN Earnings Applied to Grant

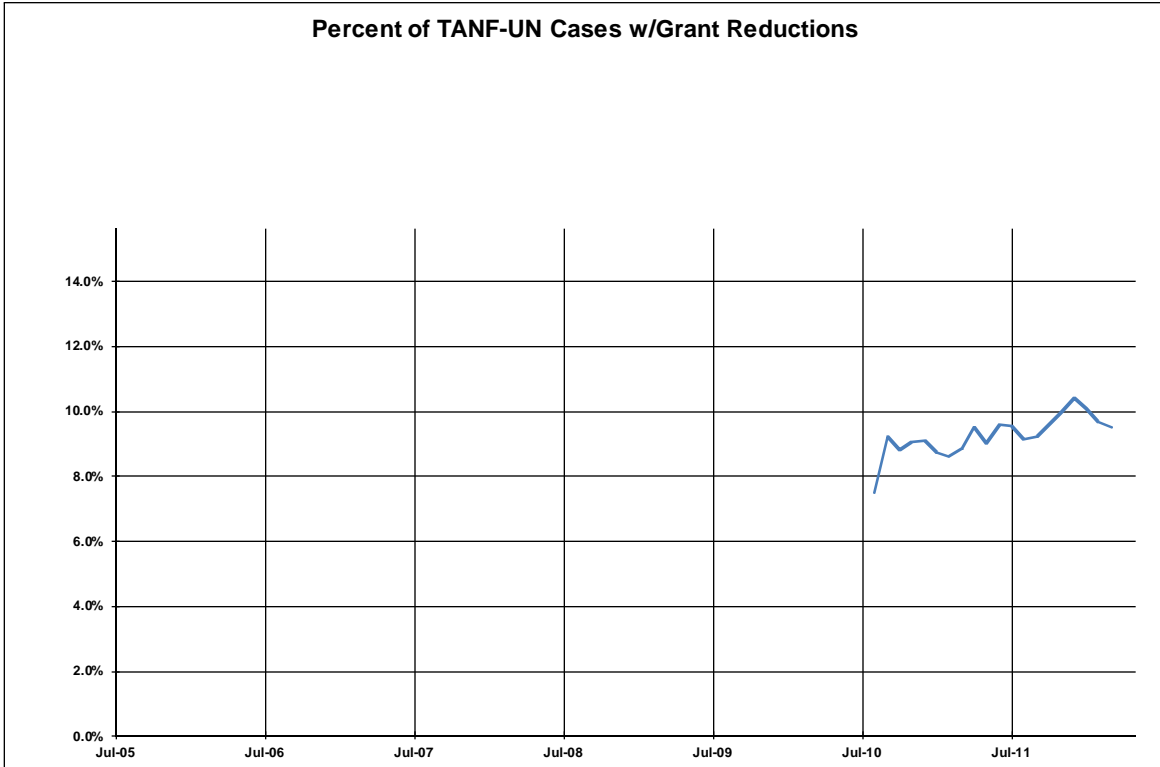

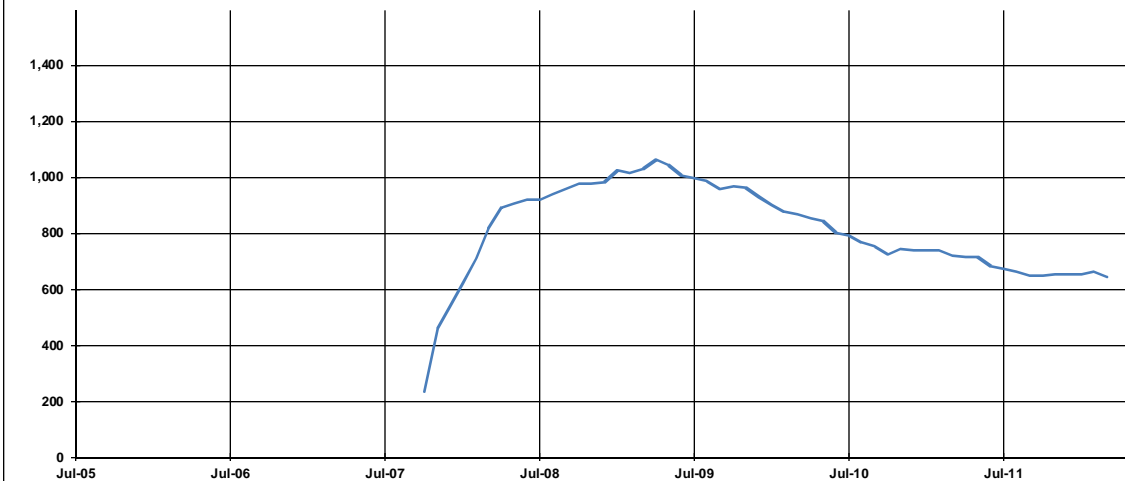
Percent of TANF-UN Cases w/Grant Reductions

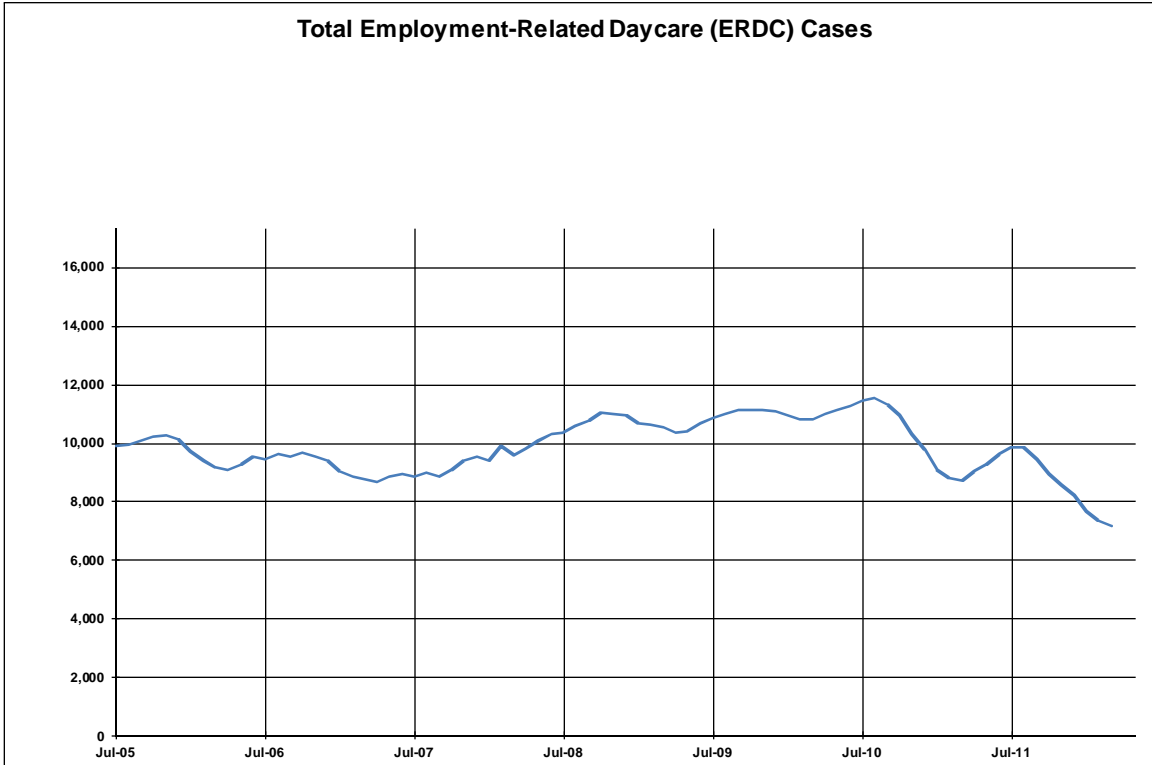
Total Employment Placements (TANF)

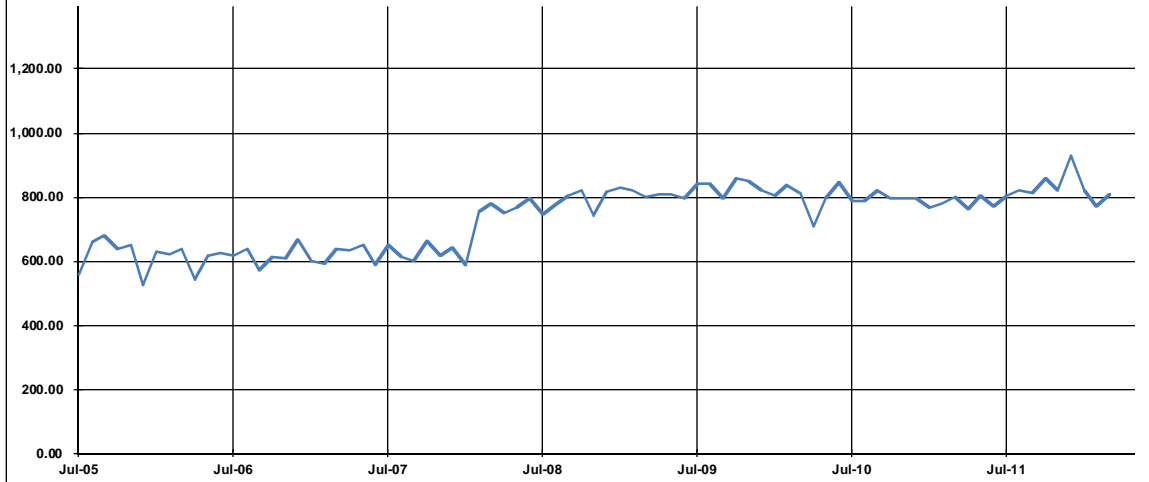

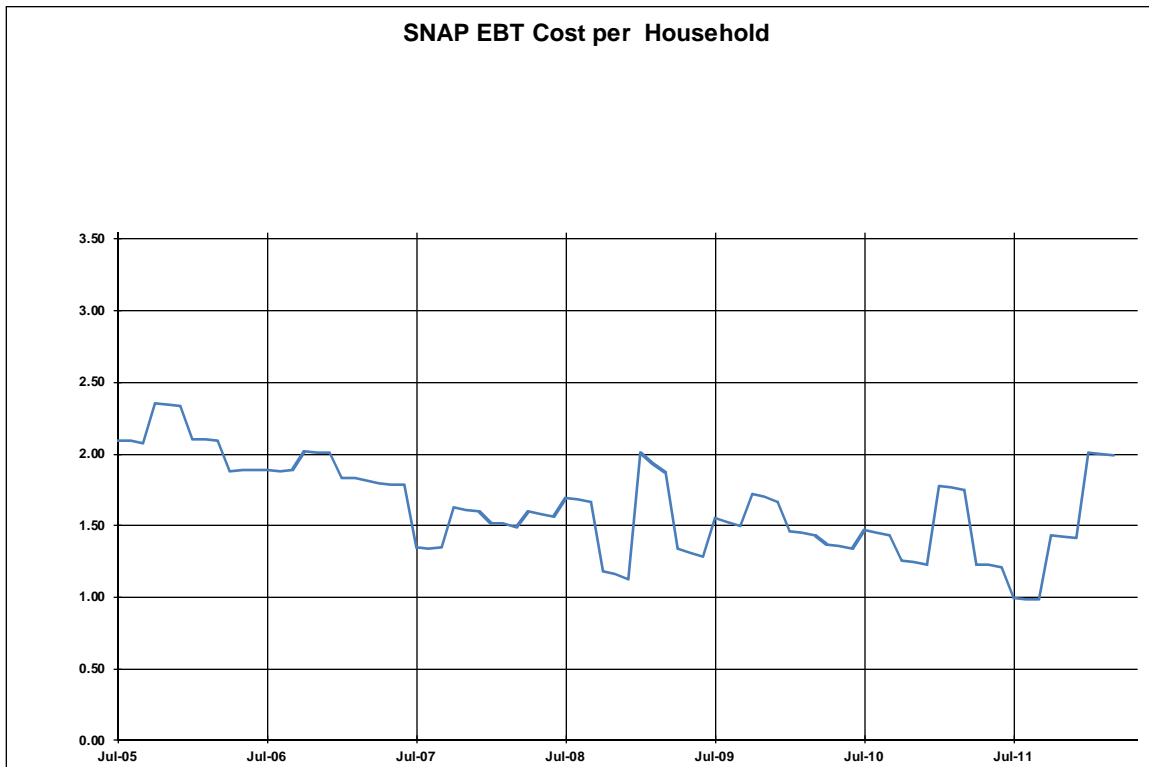
Total Statewide SNAP EBT Distribution Costs

Employment Data - Number Of Persons Unemployed in Oregon



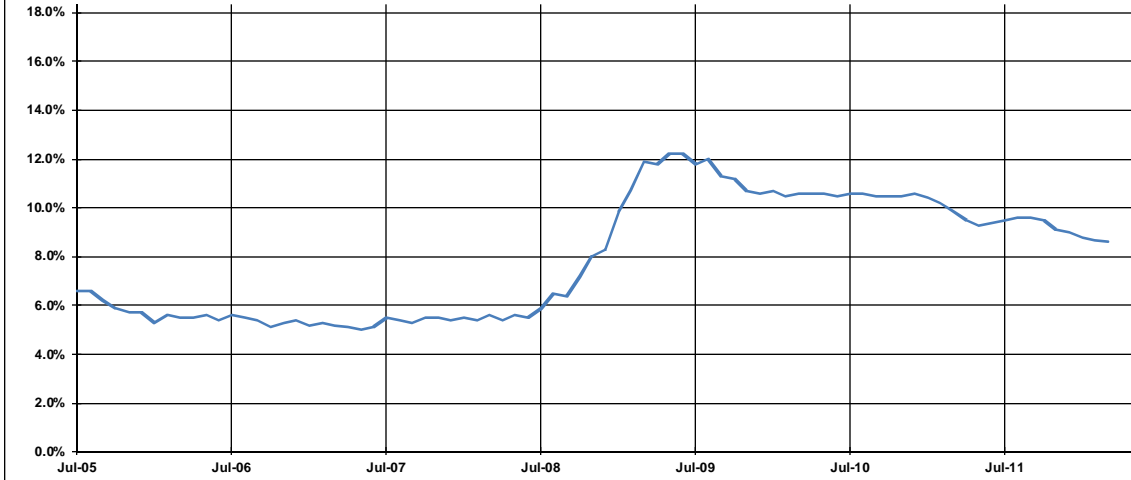

Unemployment Rate, Not Adjusted (Oregon Data)



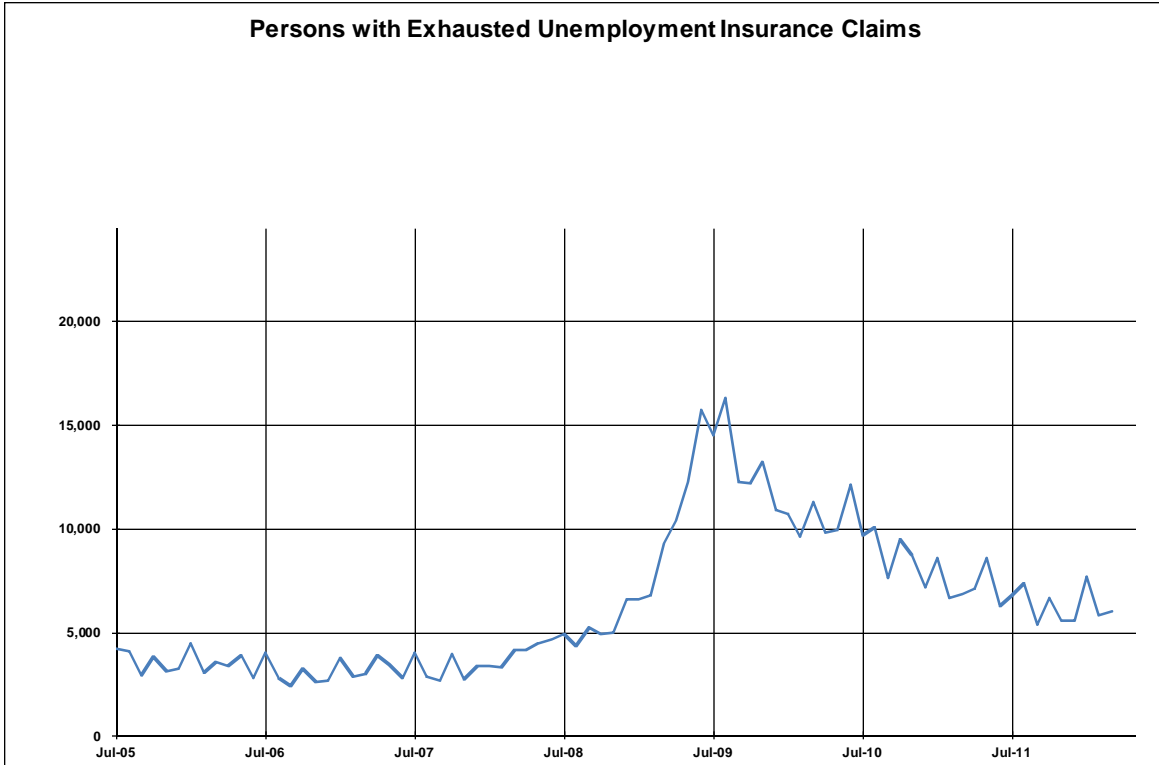

- 5A, 5B, 6A, 6B, 7A, 8A, 8B, 11B, 12A, 12B, 13B,** As of November 2003, the Pre-TANF (formerly known as Assessment) case count and the Pre-TANF person count are no longer included in the TANF Basic and TANF UN case and person count. In October 2007 the State Family Pre-SSI/SSDI program was implemented. The case count and person count for this program was included in the TANF Basic and UN counts until June 2008 when we obtained the expenditure data for the State Family Pre-SSI/SSDI program. The caseload decline in June of 2009 is attributed to a change in policy for the Non-Needy Caretaker Relative caseload which now requires the family income – which includes the caretaker and family – to be below 185% of the FPL.
- 7B, 8A, 8B, 13A, 13B, 14A** The TANF expenditures include TANF program expenditures, JOBS program expenditures, and JOBS Plus program expenditures, excluding JOBS Plus Child Care. Effective June 2008 (which was the first month we received expenditure data) the State Family Pre-SSI/SSDI program is not included in the TANF expenditures.
- 9A, 9B, 10A, 10B, 11A, 14B, 15A, 15B, 16A, 16B** The monthly reporting system, which was based upon retrospective budgeting, was discontinued April 1, 2010. Now the earnings are based upon prospective earnings and we anticipate and average the earnings that are used in the calculation of the benefit amount.
- 17A, 17B** The Pre-SSI/SSDI program and the Post-TANF programs began October 1, 2007.
- 19A, 19B** As of November 2003, the methodology used to capture the Pre-TANF (formerly known as Assessment) participants changed. We now are able to report the number of Pre-TANF participants who received a payment and those who did not receive a payment.
- 21B** “Total JOBS Participants” includes Pre-TANF Program participant counts. Effective with March 2003 data, the count is unduplicated, whereas before, it was duplicated.
- 23A** Effective July 1, 2009 Pre-SSI/SSDI clients are included in the mandatory participation count.
- 24A** Starting with September 2001 data, all placements recorded are for TANF only cases. Prior to this, the placements included Food Stamp as well as TANF placements. As of July 1, 2007, the criteria for recording placements changed.
- 24B, 25, 26,** As of January 2008 the data source for ERDC cases and children in care was updated. As of October 1, 2007, the totals do not include the Student Block Grant program as it was transferred to the Oregon Student Assistance Commission.
- 33A, 33B, 34A,** There is currently no funding for non-domestic violence Emergency Assistance. TA-DVS (Domestic Violence EA) is still funded. As of February 2008, we began reporting all cases receiving a TA-DVS service, and whether or not they received a payment. The data source was updated at that time. The cost per case indicates the costs for only the cases receiving a payment.
- 34B, 35, 36, 38, 39, 40A,** As of February 2008 data is pulled from the SNAP management information system. The Food Stamps program name changed to Supplemental Nutrition Assistance Program (SNAP) on January 1, 2010.
- 37A, 37B,** EBT Stands for Electronic Benefit Transfer.
- 40B, 41A** Consumer Price Index information comes from the Bureau of Labor Statistics. These graphs depict information based upon an index of 1982-84 equals 100.

NOTE: All expenditures in this book represent payments made during the data month, but may not be for services provided in the data month. Day care payments, especially, may be for services received one or two months prior to the data month shown. Negative expenditure amounts are caused by refunding from prior months' expenditures.
