Oregon clam harvesters must sell all commercially harvested clams intended for human consumption to Oregon Shellfish Dealers that are not listed on the ICSSL (Interstate Certified Shellfish Shippers List).

Certified Dealers must tag and label shellfish for wholesale to restaurants and retail stores.

These firms which are not on the ICSSL can not distribute shellfish products outside the state of Oregon unless it has been dyed for use as bait.
